The Cash Balance in the Aspiration Sweep Network is swept to an FDIC-Insured interest-bearing account at one or more Priority List of Banks. All assets of the account holder at the depository institution will be counted toward the aggregate limit. We will investigate your complaint and will correct any error promptly. If we take more than 10 business days to do this, we will credit your account for the amount you think is in error, so that you will have the use of the money during the time it takes us to complete our investigation.
