Green Dot must allow you to report an error until 60 days after the earlier of: (i) the date you electronically accessed your registered payment account information on your device, provided the error could be viewed there; or (ii) the date we sent the first electronic transaction history to you for your registered payment account on which the error appeared. When notifying Green Dot, you will need to tell Green Dot: (i) your name; (ii) why you believe there is an error and the dollar amount involved; and (iii) approximately when the error took place. Green Dot will determine whether an error occurred and will correct any error promptly. If Green Dot takes more than 10 business days to do this, Green Dot will provide a provisional credit to your payment account for the amount you think is in error, so that you will have the use of such amount during the time it takes Green Dot to complete our investigation.

Direct Payments Service

The Direct Payments Service allows you to use funds in your payment account to make payments to certain eligible business that you authorize. The Direct Payments Service is provided by Apple Payments, a licensed money transmitter located at 20450 Stevens Creek Blvd., Suite 130, Cupertino, California 95014. Direct Payments are identified in this statement as payments to the relevant business. There are no fees for using the Direct Payments Service. Direct Payments are not refundable, except as may be required by law. For customer support for a Direct Payment, please call (877) 255-5923.
